Enduro Royalty Trust Announces Monthly Cash Distribution

AUSTIN, Texas—(BUSINESS WIRE)—April 19, 2016

Enduro Royalty Trust (NYSE: NDRO) (the “Trust”) today announced a cash distribution to the holders of its units of beneficial interest of \$0.007279 per unit, payable on May 13, 2016 to unitholders of record on April 29, 2016. The distribution primarily represents oil production during the month of January 2016 and natural gas production during December 2015.

The following table displays underlying oil and natural gas sales volumes and average received wellhead prices attributable to the current and prior month net profits interest calculations.

Oil cash receipts for the properties underlying the Trust totaled \$2.0 million for the current month, a decrease of \$0.2 million from the prior month calculation. The decrease was primarily due to a thirteen percent decline in NYMEX oil prices. Natural gas cash receipts were consistent with the prior month, totaling \$0.7 million.

Total direct operating expenses, including lease operating expenses, production and ad valorem taxes, and gathering and transportation expenses, declined slightly to \$2.2 million as compared to \$2.4 million in the prior month distribution calculation. Capital expenditures included in the current month distribution totaled \$0.1 million. Total direct operating expenses and capital expenditures relate to expenses incurred during February 2016.

About Enduro Royalty Trust

Enduro Royalty Trust is a Delaware statutory trust formed by Enduro Resource Partners to own a net profits interest representing the right to receive 80% of the net profits from the sale of oil and natural gas production from certain of Enduro Resource Partners’ properties in the states of Texas, Louisiana and New Mexico. As described in the Trust’s filings with the Securities and Exchange Commission, the amount of the periodic distributions is expected to fluctuate, depending on the proceeds received by the Trust as a result of actual production volumes, oil and gas prices, the amount and timing of capital expenditures, and the Trust’s administrative expenses, among other factors.
